Is Healthcare FWA still a challenge in 2012?



- Healthcare FWA in the USA approaching \$300bn per annum
- 2020 alone 300 individuals charged with FWA to the extent of \$6bn
- In RSA up to 15% of all claims were estimated to be associated with FWA
- Using the 2019 figures of approx. R194bn claims paid, this translates to approx. R29bn per annum
- Funds that could have been utilized to address priority health needs
- Sufficient to provide Covid-19 vaccines to achieve herd immunity (R10bn allocated for the provision of Covid-19 vaccine)



Top 10 Healthcare Provider FWA (USA)



- 1.Billing for services not rendered.
- 2. Billing for a non-covered service as a covered service.
- 3. Misrepresenting dates of service.
- 4. Misrepresenting locations of service.
- 5. Misrepresenting provider of service.
- 6. Waiving of deductibles and/or co-payments.
- 7.Incorrect reporting of diagnoses or procedures (includes unbundling).
- 8. Overutilization of services.
- 9. Corruption (kickbacks and bribery).
- 10. False or unnecessary issuance of prescription drugs.
